The Long Road Back

Homeless, unemployed and addicted to drugs and alcohol, Michelle Faultry had given up the luxury of having a choice. Her three sons sat angry and afraid while she was escorted from the Child Protective Services (CPS) office – sobbing both her apologies and her goodbyes.

While Montego (12), Marquis (10) and Mitchell (3) were transported to a foster home by a caseworker, their mother went to a relative's house and got high.

"It felt like someone was cutting my heart out," says Michelle. "I thought the drugs would dull the pain, like they always did – but it didn't work that day."

Michelle recalls the hours following as she made up her mind that she was done using drugs and alcohol. "I took all my paraphernalia out to the curb and threw it away," she says. "I told myself that if I was going to help my kids, I had to help myself first."

And that she did. Michelle promptly checked into a 90-day inpatient drug treatment program and made herself a model resident.

Soon after, at a court hearing regarding the boys, Michelle first met Alison Meyers, the court appointed advocate volunteer assigned to the case.

Alison's role as court appointed advocate was to act, in effect, as an extra pair of eyes and ears for the family court judge. She would visit the children in their foster home, contact caseworkers and counselors, interview Michelle and other relatives, ensure necessary medical care, look out for educational interests and, ultimately, make recommendations in court regarding the permanent placement of the children.

"I didn't really understand exactly what she was supposed to do, but I could tell from the beginning that she wanted what was best for my kids – and since I wanted what was best for my kids, we had that in common," says Michelle.

Alison visited the boys often in their foster home and communicated regularly with their foster mother. She kept in close contact with their schools and therapists, looked into summer programs for them and established that their maternal great aunt was willing to take them into her home if approved by CPS.

In Harris County alone, 4,800 children languish in foster care because of life threatening abuse or neglect. Alison also attended many of the supervised visits between Michelle and the boys at the CPS offices, noting that the children seemed to be rebuilding their ability to trust their mother – something that had been damaged significantly through her years of drug abuse and their resulting placement in State custody.

"We ran into a challenge regarding the boys going to live with Michelle's aunt and her husband," says Alison. "A CPS caseworker was sent out to the home to conduct a homestudy but sometime between physically coming out and putting the homestudy details in writing for approval, she left the agency – and we had to start over."

Alison and her Child Advocates, Inc. supervisor, Kathy Nevarez, conducted the homestudy a second time and were able to present their recommendations to CPS and to the judge. The placement was approved and the boys were moved to the relative's home where all three of them immediately began improving – both in their behavior and in their grades.

"Without Alison, this case would have been chaos," says Michelle. "We had a lot of different caseworkers, therapists and attorneys. But I always knew that no matter how confusing it seemed, this was the one person who knew what was going on, the one person I could call on to get it sorted out."

As the months went on, Michelle worked steadily toward completing the services outlined in her State-issued family plan. Alison regularly communicated with Michelle's therapist through the Mental Health and Mental Retardation Authority (MHMRA), kept up with her aftercare at the drug treatment facility, checked in on Michelle to ensure that she continued attending Narcotics Anonymous and Alcoholics Anonymous and was able to report to the judge that Michelle had indeed secured housing and had begun working as a home health care provider through the MHMRA work program.

The case hit another stumbling block last summer, when additional CPS personnel changes on the case caused a stall in the agency getting court-ordered random urinalysis (UA) set up for Michelle.

"Michelle had done everything on her plan and we were ready to recommend that the boys start pre-placement visits in her new home," says Alison, "but despite our confidence in her progress, we knew that Michelle's history necessitated those random UAs for us to be 100% sure of our recommendations."

Because Alison knew that the delay on the UA paperwork was ultimately a delay for the entire case moving forward, she called and emailed each of the previous CPS supervisors until she was able to find one who could submit the paperwork in the interim between caseworkers assigned to the case.

"I knew that if Alison was anywhere as firm with them as she was with me, things would get done," Michelle jokes.

And they did. Once several UAs were conducted on Michelle at random and each one came back negative for any substances, Alison recommended the boys be placed back with Michelle. Last September, the judge ordered that they be returned home.

"I never thought my life could be like it is today," says Michelle. "We're renting a house, I've held my job for several years, I just got a new truck and I even put some money in a CD to gain interest. Looking back, it wasn't easy, but all the pain did nothing but make me grow," she says.

When we asked Marquis – now 12 years old and a young man of few words – if he was proud of his mom, his emphatic head-nod and a rare grin said it all.

From the CEO

Dear Friends,

It's been hard to ignore the news lately — as it seems like we hear a horrific story of child abuse almost every day. Earlier this year, we heard about the child whose genitals were severed; last month it was the child who was placed in the microwave; and just a few weeks ago, we heard about the child whose lifeless two-month old body was found in his mother's apartment with broken bones that would never have the chance to heal.

As shocking and terrible as these stories are, the worst part is that they're only the tip of the iceberg. For every child whose unfortunate fate makes the evening news, there are 10 more who you won't hear about — children who are burned, abandoned, beaten, born addicted to drugs or horribly neglected.

Child Advocates' ultimate goal is to provide a court appointed advocate volunteer to every child who needs us – and that number isn't getting any smaller.

After months of discussion with volunteers, board members and staff, our Strategic Planning Committee has laid out a roadmap for major growth over the next several years, and as you know, with major growth will come major challenges.

We cannot serve more children without recruiting more court appointed advocate volunteers. Our plan is to increase our total volunteer base by 30% by 2009 – and our success in this goal requires that we recruit 30% more *new* volunteers than we are recruiting currently.

Because we are committed to continuing our reputation of providing high quality service to the children we serve, we feel very strongly that in addition to growing our base of volunteers, we need to grow our staff and our financial resources in order to support this substantial increase.

I'm interested in hearing what you think – both in regards to the stragegic plan as well as any ideas that you might have that will help us recruit new court appointed advocate volunteers.

Perhaps you have some ideas regarding potential sources of volunteers that we may not yet have tapped into, or maybe you have an invaluable media contact you can connect with Child Advocates in hopes that they might be willing to donate public service space for one of our print, radio or television ads.



TENURED VOLUNTEERS

Our court appointed advocates commit to serving a child for a year. So why (according to our 2006 data of 488 volunteers) are 51% of them working on their third case or more?

Says one experienced volunteer: "The short and simple answer is that I quickly saw how important we were in speaking up for the kids and doing leg work on the case. My first three cases all had runaways and the kids contacted me, not the caseworker. Who would they have turned to if they did not have a child advocate? As long as that question has to be asked, I will be here for my kids!"

The staff turnover rate at CPS is at an all time high. Experience tells us that in order to have a deeper understanding of the needs of children and their families, tenure can be a key factor. In addition to hands-on work, volunteers bring their own strengths, life experiences and passion.

Our longitudinal study shows that the presence of a loving and supportive adult during childhood can make all the difference for a child, and potentially, break the cycle of abuse. CAI is fortunate to be part of a community that supports such a valuable asset: our volunteer.

Join us in recognizing our most tenured court appointed advocates – those who have worked 15 or more cases. Wow!


The Heroes Society Campaign is a targeted ask for unrestricted gifts – our annual campaign – intended to:

- Continue to build Child Advocates' legacy





A maternal grandmother talks about the difference Patricia Eike, a court appointed advocate volunteer since May 2006, has made on her family's case.

My name is Ms. Turner and I want to tell you about the volunteer for my three grandchildren (ages 3,2 and 1) – her name is Pat. I still feel funny calling her a "volunteer" – I thought she was getting paid for all the work she did for our family and couldn't believe when I found out she wasn't!

When my grandchildren were taken into custody, I quickly learned that working within the system isn't easy. It's hard to get a hold of people on the phone and often takes a lot of patience and persistence to get the ball rolling. Pat had a wonderful ability to somehow make things happen when I had all but given up.

When I had trouble connecting with CPS, Pat made it happen. She called the caseworker and supervisor regularly to make sure things were moving forward. When I couldn't get a referral from my doctor so that my oldest grandson could get an evaluation, Pat called the doctor's office every day until I received it. When CPS told me they couldn't approve my home for placement until I had a baby bed for the youngest one, Pat took advantage of the many resources available to her through Child Advocates and had a bed and mattress delivered to my house within weeks.

Without Pat, I think we would still be in a long, drawn-out process. She kept up with all the different caseworkers we have had. They would change so often, I had to call Pat to find out what caseworker was assigned to my case!

Because the children are so young, they can't put their feelings for Pat into words. But I know that they trust her, as she has shown them how much she really cares. When she comes around, all three of the kids run to her – even my little granddaughter, who never goes to anyone besides me!

Basically, Pat is just really, really good and has been such a blessing for me and my grandchildren. I hope that she will remain a part of our lives even when the case is closed.
